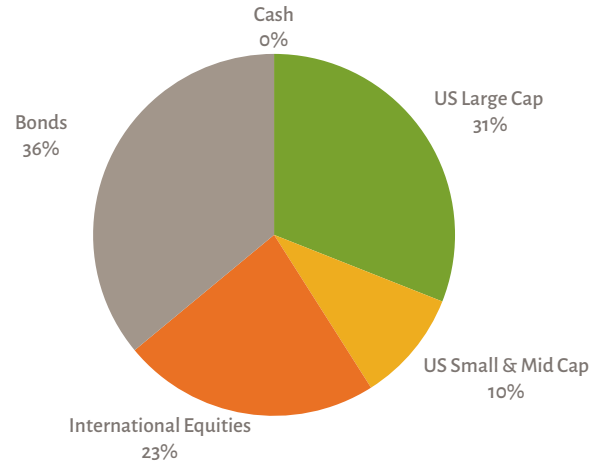

As the economy continued to open throughout Q2 post-COVID, headlines centered around rising rates and inflationary fears. Shortages in lumber, used and new cars, and housing inventory have caused short-term inflation rates to settle in higher-than-normal levels. Many economists, including Fed Chair Powell, have voiced their opinion that the current inflationary environment will prove to be transitory as economic growth and production catch up to current price levels. In any event, the equity markets continued to move ahead with the global equity index +7.4% on the quarter and +12.3% YTD. Our recent portfolio changes towards US small caps and value have been accretive to the portfolio YTD. On the bond side of the book, we saw a reversal in rising interest rates, which helped relieve some pressure from Q1. Bonds overall were positive on the quarter but remain slightly in red numbers YTD following the sharp move we saw in Q1. Our move in January to reduce portfolio duration has helped reduce interest rate risk thus far in the market cycle.
